Phil Sayer Lifetime Achievement Award

Nomination Criteria

The Phil Sayer Lifetime Achievement Award sponsored by Volunteer Firemen's Insurance Services (VFIS), in conjunction with the Fire Fighters Association of Missouri (FFAM) annually honors an individual whose remarkable lifetime achievements in the Missouri fire service and community exemplifies outstanding performance. Nominated by their peers, the recipient is presented with an award and a place in FFAM history.

The following conditions should be considered when submitting a candidate's nomination:

- **SUBMISSION DEADLINE:** Nominations must be received by February 28 of the year presented
- Individual selected must have given outstanding service to his or her Missouri fire organization, which may include county an/or state organizations.

The committee, supervised by the FFAM Award Committee, will review all names and information submitted for consideration. The committee reserves the right to reject all nominations and select an individual that has served the fire service and community to their fullest capabilities.

If a name is submitted from a member agency and an individual from the same agency is on the committee, the President of the FFAM shall nominate another individual to replace the committee member.

- No more than one award shall be presented at the annual Convention. A husband and wife nomination shall be considered as one individual.
